- 1. The Board of Trustees confirms its decision made through Motion No. 1406 (23-6-20) that Trustee Dametto-Giovanozzi contravened section 218.1 of the *Education Act* and Policy 1.02: *Code of Conduct – Trustees* by:**
 - **not upholding the implementation of a Board of Trustees' Resolution;**
 - **inserting herself into operational matters that the Board of Trustees entrusts to the Director of Education as required by the *Education Act*;**
 - **publicly expressing discriminatory views that run contrary to DPCDSB's policies and overall values as a Catholic education system;**
 - **publicly disclosing details of an in-camera motion;**
- 2. The Board of Trustees hereby vary the sanctions imposed on Trustee Dametto-Giovanozzi in Motion No. 1406 (23-6-20) effective the day they were imposed by replacing them in their entirety with the following:**

Trustee Dametto-Giovanozzi is hereby censured as a result of her contravention of Section 218.1 of the *Education Act* and Dufferin-Peel Catholic District School Board's Policy 1.02: *Code of Conduct – Trustees*.
