Under the *School Boards Collective Bargaining Act*, the Council of Trustees' Associations and the Provincial Government negotiate centrally with the various Teacher Federations and Education Workers Union.

The Dufferin-Peel Catholic District School Board (DPCDSB), and all English Catholic District School Boards, is represented at Central (Provincial) Bargaining with the Ontario English Catholic Teachers' Association (OECTA) and at the Education Workers Union tables by the Ontario Catholic School Trustees' Association (OCSTA).

The Ontario English Catholic Teachers' Association (OECTA) has announced that it will engage in a one-day full withdrawal of services on Tuesday, January 21.

**If a tentative agreement with the Government of Ontario, the Ontario Catholic School Trustees' Association (OCSTA) and OECTA is not reached in advance, the DPCDSB will, out of an abundance of care for the safe supervision of students, close schools to students on Tuesday, January 21.**

Student transportation will also be cancelled on Tuesday, January 21.

Childcare Centres in DPCDSB schools will be open on January 21.

Before and After School Programs (for school-aged children) operated by PLASP are cancelled, however, Before and After School Programs operated by YMCA and Family Day providers will offer a full-day program. Please contact the extended day service provider at your school regarding program offerings.

Permits in DPCDSB schools and facilities are not impacted and permitted activities will proceed as scheduled.

We anticipate that picketing will occur at schools and other DPCDSB locations. Peaceful picketing is lawful for the purpose of obtaining/communicating information. There is a legal obligation on the part of anyone crossing or attempting to cross a picket line to do so in a manner that does not endanger the safety of any person. Picketers can stop an individual and speak for a short period of time without breaking the law. When driving a vehicle, approach the picket line from the right-hand lane in order to avoid traffic congestion.

On January 15, the Ontario government announced that it will provide financial support for parents/guardians during strikes. Eligibility is limited to parents/guardians whose children are enrolled in a school or attending a school-based child care centre that is fully closed due to a strike. Eligible parents/guardians of children up to age 12 (Grade 7), or up to age 21 for children and youth with special needs, in a publicly funded school, qualify for:

- \$60/day for children aged 0 to 6 who are not yet enrolled in school, but attend a school-based child care centre that is required to close on account of a strike
- \$40/day for students in Junior (JK) or Senior Kindergarten (SK)
- \$25/day for students in Grades 1 to 7
- \$40 total/day for students in JK to Grade 12 (or aged 21 and under) with special needs

We will continue to communicate frequently through Community Information Bulletins sent to DPCDSB parents/guardians who have registered contact email addresses with their child(ren)'s school. These bulletins are sent via SchoolMessenger. If you have not provided a contact email address to your child(ren)'s school, we encourage you to do so.

We respect that the imposition of sanctions is a legal part of the collective bargaining process. DPCDSB actions during any job action will focus on the safety and well-being of the students entrusted to our care and to our staff.

We continue to pray for a speedy resolution and please be assured that we will continue to keep you updated as developments occur. Again, we encourage you to closely monitor the DPCDSB communication channels outlined above.
