F Director's Address to the Board—Marianne Mazzorato

Your Excellency, members of the Board of Trustees, student trustees, fellow staff and guests, it is my privilege and honour to serve as the fifth Director of Education in the 50-year history of the Dufferin-Peel Catholic District School Board. In this regard, it has been a tradition for the Director to address the Board of Trustees and the assembly at the annual Organizational Meeting.

This evening, as trustees contemplate new beginnings in the organization of the Board, we also celebrate the beginning of the new church year, a time for us to prepare for the birth of Jesus and an occasion to model outreach in justice and love to one another.

In our schools, corporate offices, parish life, and in our personal and family life, a central biblical theme that should guide us during Advent, and throughout the year, is that of

stewardship. A steward is a servant, and we, who represent many vocations and roles, take up our call to serve in Catholic education because of our strong conviction toward the faith formation of our students; dedicated to nurturing their mind, body and soul to the fullness of life, thereby changing the world through Catholic Education. We do so in the context of relationship.

Individually we, as Catholics, have a relationship with God, through prayer and communion. This is the ultimate relationship and the one that sets the stage for who we are. But, we in Dufferin-Peel also work in community with others toward the goals established by the Board of trustees and we are humble enough to recognize that the contribution that Dufferin-Peel makes to the success of Catholic education in this province is through our attentiveness to nurturing and sustaining trusting relationships.

Trusting relationships are at the heart of what it means to serve in this Board. We continue to nurture relationships with our parishes, Catholic partners, the Archdiocese of Toronto, the Ontario Catholic School Trustees Association, the Institute for Catholic Education, the Catholic Curriculum Corporation, OCSTA, and the Assembly of Catholic Bishops of Ontario to name but a few.

We strive to nurture trusting relationships with our co-terminus school boards, our unions and Associations.

We encourage teacher/student relationships that embody trust and an openness to learning and teacher/teacher relationships, guided by our school leaders and supported by senior leadership and central staff, that promote collaborative learning opportunities and innovative practice.

Our attentiveness to nurturing and sustaining trusting relationships becomes ever more important during times of challenge. This board, for 50 years, has faced and overcome a myriad of challenges. I am confident that we, too, will overcome the challenges that face us today and, in the months ahead. Because, we are a people of hope committed to nurturing trusting relationships. More importantly, and as referenced in today's scripture readings, because we put our trust in God.

Pope Francis reminds us that advent is a journey toward a horizon of hope. For us in Dufferin-Peel, we renew, always, the common horizon toward which we are journeying.

During this advent, may all of us continue to be filled with hope, joy and love; taking time each day to place prayer at the center of our lives and to open our hearts with care and compassion to all whom we encounter each day. And, in so doing, cherishing the gift of the relationships we

have in Dufferin-Peel in service to supporting our students to Believe, Excel, Thrive, Trust and Respect.
