**Criteria for Extended French (EF) Application in DPCDSB:**

- A. In Dufferin-Peel Catholic District School Board (DPCDSB), Extended French (EF) is an optional program offered in designated schools. EF program locations are subject to annual review. Students in the EF program may be required to change sites at any grade level.
- B. As well as locations of EF schools, Bus Transportation is subject to annual review and DPCDSB Policy. At present, transportation is provided by the DPCDSB to the designated EF location, provided student lives in the catchment area.
- C. It is the responsibility of the parent/guardian to confirm the designated location for your child with the [Mississauga Boundary Map](#), [Brampton Boundary Map](#), [Caledon/Dufferin Boundary Map](#) or with the DPCDSB Planning Department at 905-890-1221.
- D. To help applicants make an informed decision about entering the Grade 5 EF program, parents/guardians are encouraged to review/complete the optional *Extended French Student Information Sheet – Part A* and to confer with the classroom teacher and/or FSL teacher to review the Consideration Checklist in *Part B*.
- E. A complete application consists of uploading this *Application Form* and a PDF copy of the applicant’s *Grade 4 Term 1 Report Card* to the EF online *Application Link* (found <https://www3.dpcdsb.org/programs-services/languages/extended-french>).
- F. Only one application per child can be submitted to a student’s designated EF site. Students are NOT guaranteed entry into another EF site. DPCDSB does not assume responsibility for applications submitted to incorrect EF sites.
